- Challenges in working with OSY at the state level: IMEC presentation
 - Scheduling, logistics, matching personnel to meet the limited window of time to work with OSY (can hire 1 FT person but what about their huge caseload, hire multiple people, how do you manage all the staff)

- Make sure that we talk about migrant: we also focus on OSY and their needs
- How do the changes in allowing undocumented status (new mandate)- what does it mean to be in school? Work toward status? Enrolled in Plazas?
- Historical perspective: IMEC has influence on definitions. We should share our rationale as a Consortium. IMEC can help with this.
- Transportation (signed up for GED but have no way to get there)
- Instruction of OSY is different from traditional K-12. Know what OSY want/get their attention and teach them.
- o GED sites asking for social security numbers. Is this happening in other states?
- o Computerization of GED testing- access issue?
- Goal to graduate students- IMEC could help influence policy on this/ help to remove barriers to access
- Some OSY who aren't of an age to get into ABE- road blocks- how will this change with the minimum age of drop out to 18- will this affect the pathway to obtaining a GED or HS Diploma
- IMEC can suggest ways to change GEPRA to help measure real progress with OSY in achieving their goals
